FOR MOST PROGRAMS, STUDENTS ARE ELIGIBLE FOR UP TO \$11,000 PER YEAR IN ASSISTANCE FOR POST-SECONDARY EDUCATION. DURING THE FISCAL YEAR ENDED JUNE 30, 2023, CS PROCESSED NEARLY 3,457 APPLICATIONS AND AWARDED 192 SCHOLARSHIPS TO STUDENTS.

(EMERGENCY GRANTS) CS PROVIDES STUDENTS ALREADY RECEIVING EDUCATION FUNDING FOR DEGREE PROGRAMS WITH EMERGENCY GRANTS FOR NON-EDUCATION EXPENSES.
